Insurance: All vendors are required by our insurance company to carry your own event liability insurance and name the City of Ocean Shores as additional insured. If you do not have insurance, check out ACT Insurance - www.actinsurance.com

Vendors commit to having their booth staffed during all Festival hours of operation:

Saturday 10am – 6pm and Sunday 10am – 3pm. No early departures allowed.

Load-in: Load-in will be Friday from 12noon-8pm. Vendor participants will receive a packet of instructions. There will be limited load-in on Saturday morning from 8am-9:30am. All vendors must be open and ready for business no later than Saturday morning at 10:00am.

___ **I will come Saturday morning.**

Returning Vendors: If you are a returning vendor and are accepted you can request the same booth spaces from the previous year. ___ **I would like the same booth space as last year.**

Media rights: Vendor agrees to allow Festival to photograph or record Vendor's activities and permits use of such photographs or recordings for promotional purposes.

Liability: Vendor agrees to indemnify and hold Festival, the City of Ocean Shores, and any associated organizations harmless from any and all losses, claims, actions, damages and expenses arising out of its performance or lack of performance under this Contract. Vendor assumes all risk of loss or damage to Vendor's property at any time.

Right to disapprove merchandise: Festival reserves the right at its sole discretion to prohibit the sale of any product that is unsafe; that portrays Festival or any aspect thereof in an incorrect or misleading manner; or is inappropriate or unseemly to a family-oriented event such as the Festival. The Convention Center shall have sole discretion to reject, eject, or withdraw any vendor from the show at anytime.

Protection of property: Festival insurance does not cover supplies, equipment or materials related to the activities or services of the Vendor.

Due Date: Applications must be postmarked by Friday February 7, 2020. Late applications will be considered if space is available.
